



## City of Grinnell Cash Customer Container Rental Contract

This contract is for the use of containers supplied by the City of Grinnell for limited time usage. All billing information must be obtained prior to delivery. All containers must be located in an area on site where the truck can back up to the container to hook onto. **If the container is to be located in a drive, or in an area where the truck must drive into the yard, or across a walk, the customer assumes all responsibility for damages to the afore mentioned.**

### Container sizes available: Based on Cubic Yardage

|------------------------------------------------|-----------------------------------------------------------|
| 2 Yard = 6'6" width x 3'7" length x 4' height  | \$60.00 each time dumped                                  |
| 3 Yard = 6'6" width x 6'2" length x 4' height  | \$90.00 each time dumped                                  |
| 4 Yard = 6'6" width x 6'8" length x 4" height  | \$120.00 each time dumped                                 |
| 6 Yard = 6'6" width x 10'2" length x 4' height | \$180.00 each time dumped                                 |
| 10 Yard Roll Off = Dump Truck Box              | \$85.00 each time dumped plus landfill fee @ \$62 per ton |

**Trash exceeding container capacity shall be estimated to the nearest yard.**

Payment is required prior to each dump. If a one time dump, the down payment will be applied to the container charges and any differences will be refunded or billed accordingly to the renter.

**ANY CONTAINER THAT IS ON SITE FOR 30 DAYS WITHOUT BEING DUMPED SHALL BE CHARGED A \$30 MINIMUM INACTIVITY FEE!!**

The following items are **NOT ALLOWED** to be placed into containers:

Hazardous waste materials: (paint, cleaning supplies, gas, oil, etc).

Brush and yard waste: (must be taken to the Brush/Compost Site).

Appliances: (Air conditioners, dehumidifiers, dishwashers, freezers, furnaces, microwaves, stoves, refrigerators, washers, dryers, water heaters, TV's, printers etc.), tires, propane tanks etc. **(These items can be left beside container, but will be charged accordingly).**
